

FORECAST FOUNDATION SITE TERMS OF USE

Welcome to the Forecast Foundation website (the "Forecast Foundation Site"). The Forecast Foundation OU ("Forecast Foundation") provides the Forecast Foundation Site to you subject to the following terms of use ("Site Terms"). The Forecast Foundation Site is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms").
